

STRATHMORE FOOTBALL CLUB HALL OF FAME

(As at May 2025)

1. Establishment of Committee

The Strathmore Football Club(SFC) Hall of Fame Selection Committee is selected and endorsed as a sub-committee of the SFC by resolution of the SFC Executive and comprising members appointed by the SFC Executive. The sub-committee's function is to identify Life Members suitable for induction to the SFC Hall of Fame.

2. Membership of Committee

- 2.1 The committee shall consist of seven (7) members consisting of:
 - (a) the Chairman a member of the SFC Executive or their nominated representative, elected by SFC Executive;
 - (b) the Secretary a member of the SFC Executive or their nominated representative, elected by SFC Executive;
 - (c) five(5) other members comprising players/administrators/officials representing all decades of the SFC, as elected by the SFC Executive.

2.2 Appointment of Members

The SFC Executive shall have the sole power to fill all vacancies in the Committee, by appointment of new members.

3 Role of the Hall of Fame

The role of the Hall of Fame is to recognise and enshrine Life Members who have made a most significant contribution to the SFC since its inception in 1954. To be inducted into the SFC Hall of Fame, the inductee must be a Life Member of the SFC. Other nominees may be considered in exceptional circumstances

4 Selection Criteria for Induction into the Hall of Fame

- 4.1 The Sub-Committee may elect up to a maximum of four (4) inductees in Year one(1) then a Maximum of two(2) any given year thereafter.
- 4.2 The Sub-Committee shall consider a candidate's outstanding service and overall contribution to the SFC in determining a candidate's eligibility for induction into the Hall of Fame. They are to consider a candidate's individual record, ability, integrity, sportsmanship and character.
- 4.3 The number of football games played, coached or honorary years of service provided shall only be a consideration and shall not be determinative in assessing a candidate's eligibility.
- 4.4 For players, individual brilliance and outstanding impact is most likely evidenced by individual awards and games played, with a minimum of 200 games played for consideration
- 4.5 For non-players, a major landmark achievement which has had a significant or lasting impact on the SFC along with longevity of service with a minimum of service of 10 years required to be eligible.
- 4.6 Candidates shall be adjudged on the basis of their overall contribution to SFC, as opposed to one specific aspect.
- 4.7 A member of the Committee may be a candidate but shall not vote for his or her induction into the Hall of Fame.
- 4.8 Should a member of the Hall of Fame engage in conduct deemed to bring the SFC into disrepute such as charged with an indictable offence or engage in conduct deemed unsuitable, the SFC Executive has the right to suspend or remove the inductee from the Hall of Fame.
- 4.9 An inductee may be inducted posthumously

5 Selection Process

- a. Selections by the sub-committee shall be presented to the SFC Executive for endorsement.
- b. Nominations shall be made in a form to be prescribed by the sub-committee and shall be accompanied by information supporting the candidates eligibility.
- c. The quorum required for the sub-committee meetings shall be not less than 50% voting members present including the Chairman or such other members as may be determined by the SFC Executive.

6 Legends

There shall be a special category of inductees of the Hall of Fame known as Legends. The status of Legend will be applied to honour those SFC Hall of Fame members who have had the most significant and positive impact on the SFC.

Legendary status will be bestowed on SFC Hall of Fame members whose achievements have inspired and motivated others and whose standing and regard has reached iconic status over many years.

Legends should be (Hall of Fame Members) who immediately come to mind when discussed.

Legend Status can be bestowed on one (1) person in the inaugural year (2024) only.

Legend Status can be bestowed upon not more than 10% of inductees to the Hall of Fame with a maximum of one every two years.

The process for selecting and enshrining Legends will be the same as induction into the SFC Hall of Fame.
